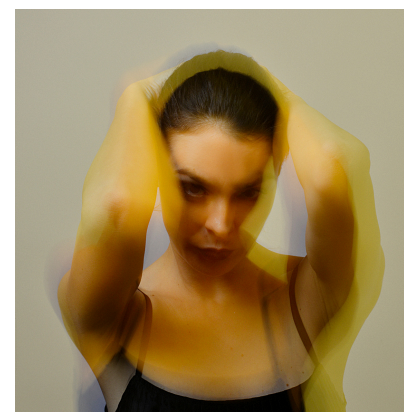
biography

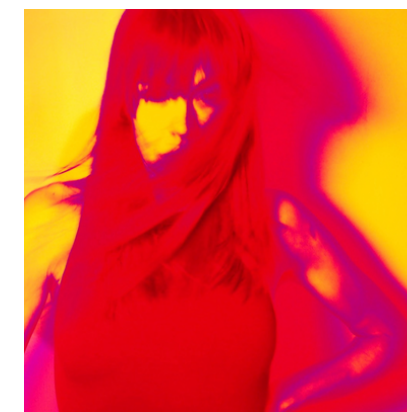

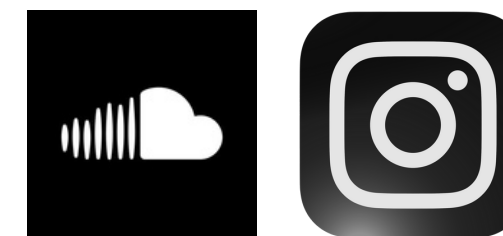

ANUSHKA

- Compliance with the host and technical rider requirements is the key to a successful performance.
- **Some of these requirements may be amended upon prior agreement.**
- All proposed changes must be discussed between the organizer and the artist's representative before the event; otherwise, all specified conditions must be adhered to.

transport

- electronic tickets
- the organizer undertakes to book additional baggage for the artist free of charge (for transporting vinyl records)

accommodation

- the accommodation must be a hotel room of at least 4-star standard, featuring: a private bathroom; free WiFi; breakfast included;
- location close to the event venue;
- possibility of a late check-out (depending on the performance time).

transfer

The organizer is fully responsible for:

- transfer from the airport/railway station to the hotel, and vice versa;
- taxi service to the event venue.
- If the artist arranges transportation independently, they are entitled to reimbursement of transport expenses from the organizer

catering / special requests

The organizer undertakes to provide the artist with the following during the event:

- non-carbonated water – 4 bottles × 0.5 L;
- Coca-Cola in glass bottles (chilled!);
- hot tea;
- bar alcohol (upon request);
- 2 additional backstage tickets;
- a guest-free area behind the DJ booth/console;
- a fan

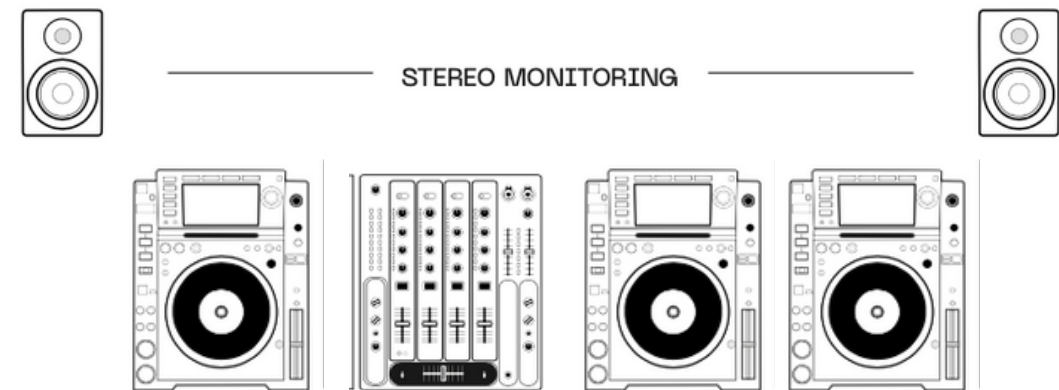

TECH & HOSPITALITY RIDER

backline required

The organizer undertakes to provide the artist with the following during the event:

- 3 units of Pioneer CDJ-2000 NEXUS players, properly linked;
- 2 units of Allen & Heath Xone 92/96 mixer; in perfect technical condition, grounded and tested;
- 2 monitors on stands (left and right), positioned at head height, with a minimum power of 300 watts each (level control available on the mixer);
- a DJ table with a height of at least 95 cm, and 1.5 meters of free space in the booth for the setup.



security requirement

The organizer must ensure adequate security for the artist and their equipment at all times. In the event of theft or damage to the artist's equipment, the organizer shall be liable for compensating the artist with the cost of replacing the damaged or lost equipment.

advertising

All promotional materials – including but not limited to flyers, posters, banners, and social media visuals – must be provided to the artist and their manager. The artist reserves the right not to publish any event-related promotional materials on their official channels.

Strictly prohibited is any audio-visual recording (filming, videotaping, live streaming, etc.) of the artist's performance without prior written authorization from the artist's manager. Violation of this clause will result in a penalty of 200 000 RUB (two hundred thousand Russian rubles).
